

JOURNEY CHURCH FRANKLIN RENTAL AGREEMENT

This instrument made and entered into on (date) _____, by and between Journey Church Franklin, hereinafter referred to as "Lessor," and _____, hereinafter referred to as "Lessee".

Said lease is made under the following terms and conditions:

1. In consideration of being granted permission to use above said space, Lessee does forever release and discharge Lessor, its successors and assigns, and its officers, employees, agents and their heirs, administrators, and executors from any and all causes of action, claims damages, liability, and loss of services which the Lessee may have against Lessor, its successors and assigns, and its officers, employees, agents and servants and their heirs, administrators, and executors resulting from any damage or injury which may or might be suffered while the Lessee has the use and/or custody of rental space.
2. The Lessee does further covenant with and agree to indemnify and hold harmless Lessor, its successors and assigns, and its officers, administrators, employees, agents, and their heirs, administrators, executors from all damage, expense, and liability that may or might be incurred while the undersigned has use and/or custody of rental space.
3. The rental price on premises shall be in the amount of _____. A deposit of _____ shall be due upon signing this contract. The rental deposit is only refundable if Lessee cancels 90 days prior to the event. Cancellations within 90 days of event receive no refund. The balance of the rental price is due prior to the setup for the event.

4. A cleaning deposit is required in addition to the rental price. It is agreed that the Lessee shall take good care of the premises hereby leased and the appurtenances thereof, and at the end of the rental term shall deliver up said premises in good order and condition. (See RENTAL GUIDELINES).

5. The Lessee does further agree to replace and/or repair any and all damage to Lessor and to replace and/or repair any and all personal property therein which may or might be damaged and/or lost while the Lessee has the use and/or custody of Lessor. It is suggested that the Lessee purchase liability insurance of \$1,000,000 (known as an Events Policy, with Journey Church Franklin listed as additional insured) to cover damages and or injuries. By electing not to have this coverage, Lessee assumes all responsibilities. (See RENTAL GUIDELINES.)

6. Lessor is not liable for failure to perform due to the power failure, weather, or any other tragedies not under its control.
